**SELLER'S RESPONSIBILITIES:**

Seller provides appropriate vaccinations for current age, worming, Micro-chipping, spay/or neutered, medical records, and a puppy pack including sample puppy food.

Warranty:

A healthy dog is extremely important to us. We want to assure that your dog is healthy and has a great temperament. Your new puppy comes with a 2 year warranty (2 years from D.O.B.) Please read our warranty below:

The Seller certifies that the above-described Labradoodle is of sound health at the time of sale. Said puppy comes with a 2 - year genetic health

guarantee against the PRCD (progressive rod-cone degeneration) form of PRA Eye Disease, Hip Dysplasia and Elbow Dysplasia. The seller will replace the dog if any of the above mentioned occurs with a dog from another litter of equal value when available at no charge other than shipping costs, or provide a refund of 50 % of the purchase price (Seller's choice). Should a problem in the puppy's health arise, the Buyer must provide all veterinary records to the Seller. This warranty does not include viral illnesses, infections or parasite infestations. It also does not include any illness due to the ingestion of foreign objects, food, chemicals or physical injury.

## BUYER'S RESPONSIBILITIES:

1) The Buyer has three days to take the puppy into a veterinarian for an examination. If the puppy is found to be of poor health the Buyer has the option of returning the puppy to the Breeder for a full refund or keeping the puppy and the Breeder will reimburse for all veterinary costs, up to the purchase price, related to the pre-existing condition.

2) The Buyer will provide the puppy a caring and loving home.

3) The Buyer will feed the puppy only a premium quality dog food.

4) The Buyer will not allow the dog to become overweight or allow repetitive, rigorous exercise during the first year of

development.

5) The Buyer agrees to never place this Labradoodle in a shelter, pound or similar sociality or research laboratory.

6) The Buyer agrees to contact the Seller immediately if the Buyer determines they are unable to keep the Labradoodle for any reason. The seller will work with the Buyer to determine how to re-home the dog.

## GENERAL INFORMATION:

We will ship your puppy (if required) at buyer's expense. The approximate cost is \$400 anywhere in the Continental United States. This cost includes a brand new crate, transportation to the

airport, airline ticket and health certificate from a state licensed Veterinarian.

Payment options include, cash, cashiers check, money order or PayPal. Note: If PayPal is used, there will be a 3.5% fee automatically added to the amount due.
